

**WHOLESALE AGREEMENT
FOR SUSTAINABLE INNOVATIONS DEVELOPMENT COMPANY, LLC**

To qualify for wholesale purchases _____ (“Retailer”), located at _____, hereby certifies that it is a valid retail business and agrees to the terms and conditions of Sustainable Innovation Development Company, LLC (“SIDC”). Retailer is only authorized to sell through the retail store that you have listed. Secondary stores, as well as website and online sales must receive prior written approval.

ORDER REQUIREMENTS

Retailers must purchase a minimum of \$300 on each order placed.

PLACING AN ORDER

Retailer may place orders through the wholesale portal on SIDC’s website, sustaininnovate.com, or by contacting a sales representative.

BASIS OF SALE

SIDC employees and/or agents are not authorized to make any representations concerning the Goods unless confirmed by SIDC in writing. In entering into the Agreement, Retailer acknowledges that it does not rely on, and waive any claim for breach of, any such representations which are not in writing. No variation to this Agreement shall be binding unless agreed in writing between Retailer and SIDC.

PAYMENT INFORMATION

We accept payments via check, credit card or Paypal. If utilizing credit or Paypal, Retailer will be responsible for an additional service fees charged to SIDC. No orders will be processed until the payment is received.

All shipping charges will be added to the invoice for each PO. We reserve the right to alter our prices at any time unless prior invoiced.

SHIPPING & HANDLING

The Retailer incurs the shipping costs. Orders received Monday through Thursday will be shipped within two (2) business days. Orders received on weekend days (Friday- Sunday) will be shipped on the next following business day. We do not ship on Fridays to prevent orders from sitting in hot postal warehouses over the weekend. Orders placed on a Federal holiday will be shipped the following business day. SIDC ships via USPS First Class mail or Fed-Ex.

PRICING POLICY

All SIDC products have a Manufacturer’s Suggested Retail Price (MSRP) as specified in Column 2 of the attached price sheet. Retailers retain the right to charge above the MSRP; however, they may not charge less than 10% below the MSRP without the written approval of SIDC, and typically will only be granted on a semi-annual basis.
