

“BUCKBEE WEED CO.”

LIABILITY WAIVER FOR THC PRODUCT TESTERS

Sustainable Innovations Development Company, LLC and Buckbee Seed Co., LLC, SEED I, *et. seq.*, (collectively referred to as “Buckbee Weed Co.”), agrees to offer certain hemp and hemp-derived products (“Products”) to the undersigned THC Product Tester (“Tester”), in exchange for information and feedback from the Tester regarding his or her experience with the Products.

I, Tester agree to perform the following as part of the Test:

- use the Product beginning within three (3) days of receiving the Product;
- respond truthfully to a questionnaire requesting demographic and other personal and non-personal information;
- respond truthfully to all Buckbee Weed Co. surveys that may include questions around Product features such as taste, quality, effects and user experience and other Product-related questions;
- cooperate with Buckbee Weed Co.’s requests concerning the Product; and
- keep the existence, details and results of the Test and Product confidential.

I understand and agree that I will not discuss the Product with any third parties, including, but not limited to posting anything on social media until Buckbee Weed Co. provides written permission to do so or launches the Product commercially to the general public.

I acknowledge and understand that the Product may be a prototype version that is not expected to function fully or flawlessly during the Test; may contain defects and/or other problems; and may include product features that are not features that will be included in commercially available versions of the Product.

Tester acknowledges and understands that the Product may be one for which testing has not yet begun, or may still in the process of testing for compliance with regulatory standards and may not currently meet those standards.

Confidential Information

I understand and agree that the Product and Test are not publicly known, are confidential and sensitive in nature and are considered Confidential Information. I understand and agree that I will not use any information about the Product, Test or any other Confidential Information provided to me by Buckbee Weed Co. for any reason other than to complete the Test. I agree not to disclose any Confidential Information to anyone other than Buckbee Weed Co. I agree to not reverse engineer, disassemble or decompile any Products, prototypes, or other tangible objects which are provided to me. I understand and agree that “Confidential Information” means any information disclosed by Buckbee Weed Co. to me, either directly or indirectly, in writing, orally or by inspection of tangible objects. I understand and agree that Confidential Information shall not include any information which (i) was publicly known and made generally available in the public domain prior to the time of disclosure by Buckbee Weed Co.; (ii) becomes publicly known and made generally available after disclosure by Buckbee Weed Co. to me through no action or inaction on my part; (iii) is already in my possession at the time of disclosure by Buckbee Weed Co.; (iv) is obtained by me from a third party without a breach of such third party’s obligations of confidentiality; (v) is independently developed by me without use of or reference to the

Confidential Information provided by Buckbee Weed Co. to me, as shown by documents and other competent evidence in my possession or (vi) is required by law to be disclosed by me, provided that I promptly give Buckbee Weed Co. written notice of such requirement prior to any disclosure so that Buckbee Weed Co. may seek a protective order or other appropriate relief.

Privacy

I understand and agree that Buckbee Weed Co. shall have the right to use, in any manner and for any purpose, any information, gained as a result of my Test of the Product, consistent with Buckbee Weed Co.'s Privacy Policy, located at <https://buckbeeweed.com/privacy>. Such information shall include but not be limited to survey data, quotes, written or oral feedback, and related data. Buckbee Weed Co. shall have the right to use, at its sole discretion, all such information for Buckbee Weed Co.'s business purposes, including but not limited to using such information for Product improvements and data gathering. I further agree that any feedback, suggestions, ideas or other information provided to Buckbee Weed Co. as part of the Test ("Feedback") will become the exclusive property of Buckbee Weed Co. and that I will not be compensated in any way for providing Feedback, and will not retain any rights to Feedback. I hereby assign any interest I may have in and to any such Feedback.

Hold Harmless

In consideration of receiving the Product(s) from Buckbee Weed Co., as stated above, I do hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE, Buckbee Weed Co. and any affiliated companies, or their officers, agents, servants, or employees ("Releasees") from any and all liability, claims, demands, disputes and causes of action whatsoever arising out of or related to any loss, damage, or injury, including without limitation, death, bodily harm and/or injury that may be sustained by me, and/or damage to any property belonging to me whether caused by the negligence of the Releasees, or otherwise by any reason whatsoever, in connection with the testing or use of the Products, including any adverse physical or mental reactions while using the Products, lapses in judgement or physical coordination, and/or use of motor vehicles while using the Products. I am fully aware of the risks involved and hazards connected with this activity, including but not limited to my ability to operate a motor vehicle while using any Products, and acknowledges that driving while under the influence is illegal and hazardous to myself and property, other parties and their property. I VOLUNTARILY ASSUMES FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING WITHOUT LIMITATION DEATH, that may be sustained by me, or any loss or damage of property owned by me, as a result of using the Products, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES OR OTHERWISE BY ANY REASON WHATSOEVER. I further hereby AGREE TO INDEMNIFY AND HOLD HARMLESS the RELEASEES from any loss, liability, damage or costs, including court costs and attorney fees, that RELEASEES may incur as a result of my use of the Product, WHETHER CAUSED BY NEGLIGENCE OF RELEASEES or otherwise by any reason whatsoever.

It is my express intent that this Waiver of Liability and Hold Harmless Agreement shall bind the members of my family and spouse, during my life, and my heirs, assigns and personal representative, should the I be deceased, and shall be deemed as a RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE the above-named RELEASEES. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the State of Illinois.

IN SIGNING THIS RELEASE, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Liability Waiver for THC Product Testers and Hold Harmless Agreement, understand it and sign it voluntarily as an act of free will and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; Tester is at least twenty-one (one) years of age and fully competent; and Tester executes this Release for full, adequate and complete consideration fully intending to be bound by same.

Informed Consent

Buckbee Weed Co. has sought Testers for its hemp and hemp-derived Products. I understand that hemp contains cannabinoids and terpenes which have an effects on the human mind and body that have not been fully explored. I wish to assist the Buckbee Weed Co. in understanding the effects that these cannabinoids, terpenes, or combinations thereof, can have on the users. I understand and consent to using the Products, knowing that they may contain known and unknown cannabinoids, including the following:

- Delta-9 THC (Delta-9 Tetrahydrocannabinol), in concentrations less than 0.3%
- Delta-8 THC (Delta-8 Tetrahydrocannabinol)
- THCA (Tetrahydrocannabinolic acid)
- THCV (Tetrahydrocannabivarin)
- THCVA (Tetrahydrocannabivarinic Acid)
- THCO (Tetrahydrocannabinol acetate)
- CBD (Cannabidiol)
- CBDA (Cannabidiolic acid)
- CBG (Cannabigerol)
- CBGA (Cannabigerolic acid)
- CBN (Cannabinol)
- HHC (Hexahydrocannabinol)
- novel cannabinoids as discovered.

I understand that **the Products may contain new cannabinoids or cannabinoids in quantities or combinations that I am not accustomed to and which may affect me adversely.** I attest that to being over the age of 21, and fully legally competent. I acknowledge that the Products may impact my ability to operate a motor vehicle or operate heavy machinery, and assumes all risk. I acknowledge and assume this risk for any adverse affects from consuming, inhaling or otherwise imbibing the Products.

I acknowledge and understand that there are risks and hazards connected with participating in the testing of a prototype product. However, I hereby elect to voluntarily participate in the Test, even though participation in the Test may be inherently, or may become during the course of the Test, hazardous to me health. I knowingly and voluntarily assume all such risks, both known and unknown, even if arising from the negligence of the Releasees, and assume full responsibility for my participation in the Test. I agree to use the utmost caution and care to avoid injury or damage to myself and others. I further agree that prior to participating in the Test, I will inspect the Product to be used, and if I believe anything is unsafe, I will immediately cease to participate in the Test and will inform Buckbee Weed Co..

Venue

I understand and agree that this Agreement, and all disputes arising out of or related hereto or in any way concerning the Test, shall be governed by and construed under the laws of the State of Illinois, United States of America, without reference to conflict of laws principles. All such disputes shall be subject to the exclusive jurisdiction of the state and federal courts located in Winnebago County, Illinois, and the parties agree and submit to the personal and exclusive jurisdiction and venue of these courts. In any dispute related to the subject matter of this Agreement, the prevailing party in such dispute shall have the right to collect reasonable attorney's fees and court costs from the other party.

In signing this release, I acknowledge and represent that: No oral representation, statements or inducements, apart from the foregoing written Agreement, have been made; and I HAVE READ THE FOREGOING AGREEMENT, UNDERSTAND IT, AND AGREE VOLUNTARILY OF MY OWN FREE WILL.
